

1. Introduction

- 1.1. These are the terms and conditions of use of the Myenergi Installations Ltd website (Site). The Site is operated by or on behalf of Myenergi Installations Ltd (we, us and our). We are a limited company, registered in England. Our registered company number is 14585891, and our registered office is at Pioneer Business Park, Faraday Way, Stallingborough, Grimsby, DN41 8FF.
- 1.2. Your use of the Site will be subject to these terms and conditions and by using the Site you agree to be bound by them. These terms of use refer to the following additional terms, which may also apply to your use of the Site:

2. Terms of Use

- 2.1. Access to and Use of the Site

- 9.2.6 These terms may not be varied except with our express written consent.
- 9.2.7 These terms and any document expressly referred to in them represent the entire agreement between you and us in relation to use of the Site.
